Board Meeting

April 11, 2017

The Board of Education met Tuesday, April 11, 2017, at 6:00 p.m. in the Administration Office, with the following members present: Mr. Greg Farrow, Ms. Sheila King, Mr. Dan Stover, Mr. Brian Thompson, Mr. Bruce Thomas, Sara Varner, and Mr. Kelly Waller.

Board Reorganization:

Bruce Thomas turned the meeting over to the temporary chairman, Dr. John Link, Superintendent, for board reorganization.

Bonnie Stahlman, Board Secretary, administered the Oath of Office to Board Members Greg Farrow, Bruce Thomas, and Sara Varner.
